

User Terms and Conditions

These User Terms and Conditions ("Terms") govern the contractual relationship between TASKORY LIMITED ("we", "us", or "our") and users ("you" or "your") when you use service and features through this TidySafe: Photo Keeper ("App" or "Service"). Please read the Terms carefully and if you do not agree any of it, do not use our Service.
